TRAVEL INSURANCE

Greenmount Travel strongly recommends that all passengers take out adequate and appropriate comprehensive travel insurance to cover health/medical requirements, cancellations, luggage and valuables etc. Note that most travel insurance policies do not cover Covid-related border closures.

CANCELLATIONS

PLEASE NOTE: Tour cancellation for a valid reason (but not Covid-related) is generally covered by good quality comprehensive travel insurance.

The *Greenmount Travel* schedule of cancellation fees is as follows:

90 days or more prior to departure date – unused portion of deposit/payments fully refundable.

89 to 61 days prior = 100% of deposit.

60 to 31 days prior = 50% of full tour cost.

30 to 0 days prior = 100% of full tour cost.

Any extra payments such as flight upgrades or “early bird” flight bookings are only refundable according to the rules of the airline or travel provider.
